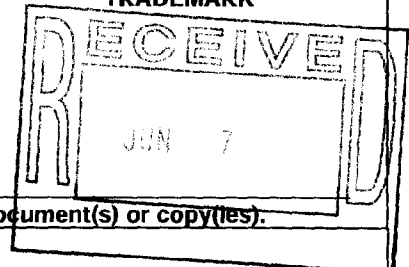

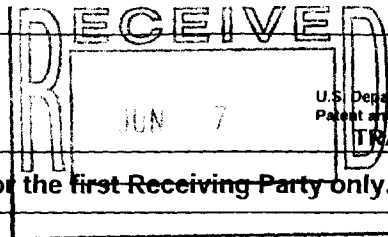

SECURITY INTEREST IN TRADEMARK**
