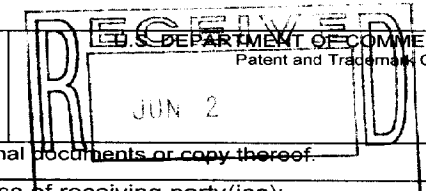

ASSIGNMENT OF SERVICE MARK


