Pursuant to the provisions of Section 31, Article

1, Chapter 31 of the Code of West Virginia, the undersigned
corporation adopts the following Articles of Amendment to its
Articles of Incorporation.

FIRST: The name of the corporation is Bright, Inc.

SECOND: The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on September χ 7, 1990 in the manner prescribed by Section 107, Article 1, Chapter 31 of the Code of West Virginia.

RESOLVED, that the Articles of Incorporation of Bright, Inc. be amended by striking out Article I thereof in its entirety and substituting therefor a new Article I as follows: "I. The undersigned agrees to become a corporation by the name of Bright of America, Inc."

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 1000 and the number of shares entitled to vote thereon was 1000.

FOURTH: The number of shares voted for such amendment was 1000 and the number of shares voted against such amendment was zero.
