**RELEASE OF SECURITY INTEREST AND COLLATERAL ASSIGNMENT OF
TRADEMARKS AND OTHER COLLATERAL**

This RELEASE OF SECURITY INTEREST AND COLLATERAL ASSIGNMENT of Trademarks and other collateral, dated as of May 11, 1999, by BANKERS TRUST COMPANY, as Trustee (the "Lender"), grants a release of security interest and collateral assignment to SALANT CORPORATION (the "Grantor") as follows:

W I T N E S S E T H:

WHEREAS, the Grantor and the Lender have entered into various collateral documents, including, but not limited to, a security agreement dated September 20, 1993 (attached hereto in Schedule B) recorded in the U.S. Patent & Trademark Office on September 20, 1993, at Reel and Frame No. 1036/0281 (as amended, restated, replaced, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, the Security Agreement and other collateral documents assigned and granted to Lender a security interest in certain of the Grantor's assets, including, without limitation, certain trademarks, service marks, tradenames and other collateral (collectively, the "Trademarks") described in the Security Agreement which descriptions are incorporated herein;

WHEREAS, pursuant to the Security Agreement and other collateral documents, the Grantor has fulfilled all obligations and commitments and requested that the Lender agree to release and assign any and all interest it may have in the Trademarks of the Grantor;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Lender agrees as follows:

1. Lender hereby releases and assigns its entire right, title and interest in all Trademarks listed in Schedule A in combination with all Trademarks listed in


Schedule II to the Security Agreement (attached hereto as Schedule B), including all goodwill symbolized thereby, connected therewith or relating thereto, and declares as null and void all liens, security interests, and other claims, including any claim of ownership, of Lender with respect to the Trademarks arising from the Security Agreement (attached hereto as Schedule B) and any other collateral documents, or otherwise.

2. This RELEASE of security interest and collateral assignment has been executed and delivered by Lender for the purpose of releasing, removing, or otherwise eliminating the security interest and assignment of Lender in the Trademarks that has been filed with the United States Patent and Trademark Office and, to the extent required, any other such offices in other countries of the world.

3. A true and correct copy of the list of all Trademarks and trademark applications is attached hereto as Schedule A and in Schedule II of the Security Agreement attached hereto as Schedule B.

4. Lender has a continuing obligation to sign all agreements, documents, or otherwise, necessary to carry out this Agreement and the obligations herein.

SECURITY AGREEMENT

THIS AGREEMENT, dated as of September 20, 1993, is entered into between SALANT CORPORATION, a Delaware corporation (herein called the "Company"), and Bankers Trust Company, as trustee acting in accordance with the terms and conditions of the Public Secured Note Indenture (as hereafter defined) on behalf of and for the benefit of the Public Purchasers referred to below. All rights and duties of the Trustee (as hereafter defined) hereunder shall only be exercised in accordance with the terms and conditions of the Public Secured Note Indenture.

W I T N E S S E T H:

WHEREAS, pursuant to the Plan and the 10-1/2% Senior Secured Note Indenture, dated as of even date herewith (herein, as amended or otherwise modified from time to time, called the "Public Secured Note Indenture"), between the Company and Bankers Trust Company, as trustee (the "Trustee") for the purchasers (the "Public Purchasers") of the 10-1/2% Senior Secured Notes of the Company (the "Public Secured Notes"), the Company has issued the Public Secured Notes to the Public Purchasers;

WHEREAS, it is a condition precedent to the issuance of the Public Secured Notes under the Public Secured Indenture that the Company execute and deliver this Agreement; and

WHEREAS, pursuant to an Intercreditor Agreement, dated as of even date herewith, by and between the Working Capital Facility Lender and the Trustee, the parties hereto have agreed that this Agreement is subject to the terms and provisions of such Intercreditor Agreement.

NOW, THEREFORE, for and in consideration of the acceptance of the Public Secured Notes by the Public Purchasers pursuant to the Plan and the Public Secured Note Indenture, and for other good and valuable consideration, the parties hereto agree as follows:

1. Definitions. Initially capitalized terms used but not defined herein shall have the meanings assigned thereto in the Public Secured Note Indenture and such terms used but not defined herein or in the Public Secured Note Indenture shall have the meanings, if any, ascribed to them under the Uniform Commercial Code as in effect in the State of New York on the date hereof. In addition, when used herein the following terms shall have the following meanings:

Account shall mean any right of the Company to payment for goods sold or leased or for services rendered, whether or not such right is yet earned by performance.

Account Debtor shall mean the Person who is obligated on or under any Account.

Collateral shall mean all property or rights in which a security interest is granted hereunder.

Default shall mean any "Event of Default" (as such term is defined in the Public Secured Note Indenture).

Equipment shall have the meaning assigned thereto in the Uniform Commercial Code as in effect in New York at the date of this Agreement, and in any event shall include, without limitation, all machinery, equipment, furnishings, fixtures, vehicles and computers and other electronic data-processing and office equipment now owned or hereafter acquired by the Company and any and all additions, substitutions and replacements of any of the foregoing, wherever located, together with all attachments, components, parts, equipment and accessories whether now or hereafter installed thereon or affixed thereto.

General Intangible shall have the meaning assigned thereto in the Uniform Commercial Code as in effect in New York as at the date of this Agreement, and in any event shall include, without limitation, (i) all rights to payment in respect of loans or advances, management fees, tax sharing or allocation fees, royalties, licensing arrangements and pension or tax refunds, (ii) all patents and copyrights, (iii) all owned or licensed trademarks and trademark registrations, trade names and trade name registrations and service marks and service mark registrations, including, without limitation, those listed in Schedule II hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each owned or licensed trademark and trademark registration, trade name and trade name registration and service mark and service mark registration, and all continuations and extensions thereof, the right to sue for infringements or dilutions thereof or for injury to the goodwill associated therewith and

all rights corresponding thereto throughout the world and (iv) to the extent not covered in clauses (i) through (iii) above, all rights of the Company under the PEI Settlement Agreement and the "Assumed Licenses" (as such term is defined in the PEI Settlement Agreement) and the proceeds thereof, including, without limitation, all of the Company's rights to receive from Perry Ellis International Inc. the royalties described in section 5(d) or 5(e) of the PEI Settlement Agreement (such items described in this clause (iv) being collectively referred to as the "PEI Rights").

Inventory shall have the meaning assigned thereto in the Uniform Commercial Code as in effect in New York as at the date of this Agreement, and in any event shall include, without limitation, (i) all inventory, merchandise, goods and other personal property now owned or hereafter acquired by the Company which are held for sale or lease or are furnished or to be furnished under a contract of service or which constitute raw materials, work in process or materials used or consumed or to be used or consumed in the Company's business, or the processing, packaging, delivery or shipping of the same, and all finished goods, and (ii) goods which are returned to or repossessed by the Company whether or not in transit, and all accessions and additions thereto and all documents of title covering any of the foregoing.

Permitted Liens shall mean (a) Liens for current taxes not delinquent or for taxes being contested in good faith and by appropriate proceedings, (b) Liens arising in the ordinary course of business for sums not due or sums being contested in good faith and by appropriate proceedings and not involving any deposits or advances or borrowed money or the deferred purchase price of property or services, (c) Liens in favor of the Trustee for the benefit of the Public Purchasers, (d) Liens securing extensions of credit under the Working Capital Facility, (e) Liens in connection with the acquisition (or, in the case of property subject to existing liens, the refinancing) of property after the date hereof, and attaching only to the property being acquired or refinanced, if the indebtedness secured thereby (including Capitalized Lease Obligations) does not exceed the fair market value of such property at the time of acquisition thereof (and, in the case of a refinancing, the amount of the existing lien), and (f) additional Liens arising in the ordinary course of business which do not materially detract from the value or interfere with the use of the properties of the Company or the Subsidiary granting such Lien or otherwise materially impair the business or operations of the Company or such Subsidiary.

2. Grant of Security Interest. (a) As security for the payment of all of the Indenture Obligations (as defined in the Public Secured Note Indenture), the Company hereby assigns to the Trustee and grants to the Trustee a continuing senior security interest in the following, whether now or hereafter existing, owned or acquired: all Accounts created prior to June 27, 1990 (the "1990 Accounts") and General Intangibles of the Company, together with all chattel paper and instruments evidencing any obligation to the Company arising on account of any 1990 Account or General Intangible; all interest of the Company in any returned or repossessed goods the sale or lease of which shall have given or shall give rise to, and in all guaranties and other property securing the payment of or performance under, any 1990 Account, any General Intangible or any such chattel paper or instruments; all books and records relating to any of the foregoing; and all proceeds (including, without limitation, all insurance proceeds) of any of the foregoing.

(b) As additional security for the payment of all of the Indenture Obligations, the Company hereby assigns to the Trustee and grants to the Trustee a continuing security interest junior and expressly subordinate to the security interest granted for the benefit of the Working Capital Facility Lender in the following, whether now or hereafter existing, owned or acquired: all Accounts of the Company, other than the 1990 Accounts, together with all chattel paper and instruments evidencing any obligation to the Company arising on account of any Account, other than the 1990 Accounts; all interest of the Company in any returned or repossessed goods the sale or lease of which shall have given rise to or shall give rise to, and in all guarantees and other property securing the payment of or performance under, any Account, other than the 1990 Accounts; all Equipment and Inventory of the Company; all books and records relating to any of the foregoing; and all proceeds (including, without limitation, all insurance proceeds) of any of the foregoing.

(c) Each Public Purchaser by its acceptance of the Public Secured Notes expressly acknowledges that the security interest in the Collateral granted to the Trustee in paragraph (b) above is junior and expressly subordinate to the security interest in such Collateral granted for the benefit of the Working Capital Facility Lender and the Trustee hereby agrees and each Public Purchaser by its acceptance of the Public Secured Notes and the benefits of this Agreement agrees that the security interest in the General Intangibles of the Company described in paragraph (a) above is junior and expressly subordinate to the security interest in such General Intangibles granted for the benefit of the Working Capital

Facility Lender to the extent of \$15,000,000; provided, that, notwithstanding anything to the contrary contained in the Working Capital Facility or otherwise, the Working Capital Facility Lender shall not be entitled to, and shall not, receive any proceeds from any sale or other disposition of any such General Intangibles unless (i) the Company is in default under the Working Capital Facility and (ii) the Working Capital Facility Lender is exercising its rights to liquidate the collateral securing the Working Capital Facility.

(d) Notwithstanding anything contained herein to the contrary, the Trustee hereby agrees that if (i) the Working Capital Facility Lender releases its liens on any of the Collateral in which it has a senior security interest (other than the General Intangibles of the Company and the Company's interest in its Winnsboro, South Carolina facility) or (ii) the Company is able to refinance the Working Capital Facility (the "Refinanced Working Capital Facility") without a Lien on any of the Collateral in which the Working Capital Facility Lender currently has a senior security interest, then the Trustee, upon (x) written notification of the occurrence of either of the events described in clauses (i) and (ii), (y) the request of the Company and (z) receipt of an opinion of counsel that satisfies the requirements of section 314(d) of the Trust Indenture Act, shall promptly release its security interest in such Collateral (other than the General Intangibles of the Company and the Company's interest in its Winnsboro, South Carolina facility) (A) released by the Working Capital Facility Lender or (B) which no longer constitutes security for the Refinanced Working Capital Facility, and deliver appropriate instruments of release and the subordination of the security interest of the Trustee in the General Intangibles as described in clause (c) of this Section 2 shall be of no further force or effect.

3. The Company to Remain Liable. The Company hereby expressly agrees that, anything herein to the contrary notwithstanding, it shall remain liable under all Accounts and General Intangibles to observe and perform all conditions and obligations to be observed and performed by the Company thereunder, all in accordance with and pursuant to the terms and provisions thereof. Neither the Trustee nor any Public Purchaser shall have any duty, responsibility, obligation or liability with respect to any Accounts, General Intangibles, Inventory or Equipment by reason of or arising out of the granting to the Trustee of a security interest therein or the receipt by the Trustee of any payment relating to an Account, General Intangible, Inventory or Equipment, nor shall the Trustee or any Public Purchaser be required or obligated in any manner to perform or fulfill any of the obligations of the

Company thereunder or pursuant thereto, or to make any payment, or to make any inquiry as to the nature or sufficiency of any payment received by it or the sufficiency of any performance of any party, under an Account or General Intangible, or to present or file any claim, or to take any action to collect or enforce any performance or the payment of any amounts which may have been assigned to it, in which it may have been granted a security interest or to which it may be entitled at any time or times.

4. Warranties. The Company warrants that: (a) no financing statement (other than any which may have been filed on behalf of the Trustee, or otherwise in connection with Permitted Liens) covering any of the Collateral is on file in any public office and is in effect; (b) the Company is and will be the lawful owner of all Collateral, free of all liens and claims whatsoever, other than the security interest hereunder and other Permitted Liens, with full power and authority to execute this Agreement and perform the Company's obligations hereunder, and to subject the Collateral to the security interest hereunder; (c) the Company's chief executive office and the offices where the Company keeps its records concerning any of the Collateral are located on the date hereof at the places set forth in Schedule I hereto; (d) all of the Equipment and Inventory are located at the places specified in Schedule III hereto; (e) all information with respect to Collateral and Account Debtors set forth in any schedule, certificate or other writing at any time heretofore or hereafter furnished by the Company to the Trustee or any Public Purchaser, and all other written information heretofore or hereafter furnished by the Company to the Trustee or any Public Purchaser, is and will be true and correct as of the date furnished; and (f) upon proper filing of financing statements, this Agreement will create a valid perfected security interest in the Collateral in favor of the Trustee.

5. Processing, Sale, Collections, etc. Until such time as a Default shall have occurred and the Trustee in accordance with the Public Secured Note Indenture shall have notified the Company of the revocation of such power and authority, the Company (a) will, at its own expense, endeavor to collect, as and when due, all amounts due with respect to any of the Collateral, including the taking of such action with respect to such collection as the Company may deem advisable, and (b) may grant, in the ordinary course of business, to any Person obligated on any of the Collateral, any rebate, refund or allowance to which such Person may be lawfully entitled, and may accept, in connection therewith, the return of goods, the sale or lease of which shall have given rise to such Collateral. The Trustee, however, may, at any time after the

occurrence of a Default, revoke such power and authority and notify any Person obligated on any of the Collateral to make payment to the Trustee of any amounts due or to become due thereunder and enforce collection of any of the Collateral by suit or otherwise and surrender, release or exchange all or any part thereof, or compromise or extend or renew for any period (whether or not longer than the original period) any indebtedness thereunder or evidenced thereby. After the occurrence of a Default, the Company will, at the request of the Trustee and at the Company's own expense, (x) notify any Person obligated on any of the Collateral to make payment to the Trustee of any amounts due or to become due thereunder and (y) take such actions as may be requested by the Trustee to collect or assist the Trustee in collecting the Collateral.

6. Agreements of the Company. The Company (a) will, upon request of the Trustee, execute such financing statements and other documents (and pay the cost of filing or recording the same in all public offices deemed necessary by the Trustee) and do such other acts and things, all as the Trustee may from time to time request to establish and maintain a valid perfected security interest in the Collateral (free of all other liens, claims and rights of third parties whatsoever other than Permitted Liens) to secure the payment of the Indenture Obligations; (b) will keep at the addresses set forth in Schedule I, its records concerning the Collateral, which records will be of such character as will enable the Trustee or any designee of the Trustee to determine at any time the status thereof, and the Company will not, unless the Trustee shall otherwise consent in writing, duplicate any such records at any other address; (c) will furnish the Trustee such information concerning the Company, the Collateral and the Account Debtors as the Trustee may from time to time reasonably request; (d) will permit the Trustee or any designee of the Trustee, from time to time at reasonable times and upon reasonable notice, to inspect, audit and make copies of and extracts from all records and all other papers in the possession of the Company relating to the Collateral, and will, upon the Trustee's request after the occurrence of a Default, deliver to the Trustee all of such records and papers which pertain to the Collateral and the Account Debtors; (e) will, upon the Trustee's request, stamp on its records concerning the Collateral (and/or enter on its computer records concerning the Collateral), and on all chattel paper constituting a portion of the Collateral, a notation, in form satisfactory to the Trustee, of the security interest of the Trustee hereunder; (f) will not sell, lease, assign or create or permit to exist any Lien (except Permitted Liens) on any Collateral to or in favor of any Person other than the Trustee; (g) will furnish to the Trustee, as soon as possible and in any event within forty-five

(45) days prior to any change in the location of the Company's chief executive office or in the Company's name, notice in writing of such change; and (h) will reimburse the Trustee for all expenses, including reasonable attorneys' fees and legal expenses, incurred by the Trustee in seeking to collect or enforce any rights under the Collateral and, in case of a Default, incurred by the Trustee in seeking to collect the Indenture Obligations and to enforce rights hereunder.

7. Remedies. Whenever a Default shall exist, all Indenture Obligations may or shall, as the case may be, become immediately due and payable, as provided in the Public Secured Note Indenture, and the Trustee may in accordance with the Public Secured Note Indenture from time to time exercise any rights and remedies available to it under applicable law or otherwise available to it. Without limiting the foregoing, upon a Default the Trustee in accordance with the Public Secured Note Indenture may, to the fullest extent permitted by applicable law, without notice, advertisement, hearing or process of law of any kind, (a) enter, with or without process of law and without breach of peace, any premises where any of the Collateral may be located and take possession of and remove such Collateral, (b) sell any or all of the Collateral, free of all rights and claims of the Company therein and thereto, at any public or private sale, and (c) bid for and purchase any or all of the Collateral at any such sale. The Company hereby expressly waives, to the fullest extent permitted by applicable law, any and all notices, advertisements, hearings or process of law in connection with the exercise by the Trustee of any of its rights and remedies upon a Default. If any notification of intended disposition of any of the Collateral is required by law, such notification, if mailed, shall be deemed reasonably and properly given if mailed at least ten days before disposition, postage prepaid, addressed to the Company either at its address shown below, or at any other address of the Company appearing on the records of the Trustee. Any proceeds of any of the Collateral may be applied by the Trustee to the payment of expenses in connection with the Collateral, including reasonable attorneys' fees and legal expenses, and any balance of such proceeds may be applied by the Trustee toward the payment of the Indenture Obligations. After payment in full of all Indenture Obligations, any excess shall be delivered to the Company or as a court of competent jurisdiction shall direct. Notwithstanding anything to the contrary contained in this Section 7 or otherwise contained in this Agreement, all of the Trustee's rights to sell, assign or otherwise transfer any of the PEI Rights are subject to, and limited as provided in, section 5(d) or 5(e) of the PEI Settlement Agreement and the instruments in the form of Exhibits I and J to the PEI Settlement Agreement.

The Company hereby irrevocably constitutes and appoints the Trustee, and any officer or agent thereof acting on behalf of the Trustee, with full power of substitution, as its true and lawful attorney-in-fact with full power and authority in the name of the Company or in its own name, from time to time in the Trustee's discretion, so long as any Default is continuing, to take any and all appropriate action and to execute any and all documents and instruments which may be necessary or desirable to carry out the terms of this Agreement and accomplish the purposes hereof and, without limiting the generality of the foregoing, the Company hereby gives the Trustee the power and right on behalf of the Company, so long as any Default is continuing, without notice to or further assent by the Company, to do the following: (i) to ask for, demand, sue for, collect, receive and give acquittance for any and all moneys due or to become due upon, or in connection with, the Collateral; (ii) to receive, take, endorse, assign and deliver any and all checks, notes, drafts, acceptances, documents and other negotiable and non-negotiable instruments and chattel paper taken or received by the Trustee as, or in connection with, the Collateral; (iii) to do, at its option and at the expense and for the account of the Company, at any time or from time to time, all acts and things which the Trustee deems necessary to protect or preserve the Collateral and to realize upon the Collateral. The foregoing power of attorney is coupled with an interest. In addition, so long as any Default is continuing, if either (x) the Trustee in its discretion determines, or (y) is directed by written request of Holders of a majority in principal amount of the Securities, to enforce its rights against the Inventory subject to the PEI Settlement Agreement ("PEI Inventory"), then the Trustee may in its sole discretion hire an agent to take, on behalf of the Trustee, any acts of enforcement that are in conformity with the terms and conditions of this Agreement and the PEI Settlement Agreement; provided, however, in no event shall the Trustee be required to take any acts of enforcement against PEI Inventory in contravention of section 6.05 of the Public Secured Note Indenture. The Trustee shall be entitled to apply any proceeds from the sale or other disposition of PEI Inventory to the payment of all reasonable fees and expenses arising from any acts of enforcement with respect to PEI Inventory. To secure the Company's obligations under this Section 7, the Trustee shall have a lien prior to that of all Holders of Securities on all money or property held or collected by the Trustee in connection with acts of enforcement against PEI Inventory. The Trustee shall exercise all of its rights and remedies under this Section 7 in accordance with the terms and conditions of the Public Secured Note Indenture and any such exercises shall be subject to receipt by the Trustee of indemnity satisfactory to the Trustee.

8. General. The Trustee shall be deemed to have exercised reasonable care in the custody and preservation of any of the Collateral in its possession if it takes such action for that purpose as the Company requests in writing, but failure of the Trustee to comply with any such request shall not of itself be deemed a failure to exercise reasonable care, and no failure of the Trustee to preserve or protect any rights with respect to such Collateral against prior parties, or to do any act with respect to the preservation of such Collateral not so requested by the Company, shall be deemed a failure to exercise reasonable care in the custody or preservation of such Collateral.

No delay on the part of the Trustee in exercising any right, power or remedy hereunder shall operate as a waiver thereof nor shall any single or partial exercise of any such right, power or remedy preclude any other or further exercise thereof or the exercise of any other right, power or remedy. No amendment, modification or waiver of, or consent with respect to, any provision of this Agreement shall in any event be effective unless the same shall be in writing, and signed and delivered by the party to be bound thereby, and then such amendment, modification, waiver or consent shall be effective only in the specific instance and for the specific purpose for which given.

All rights, powers and remedies of the Trustee and the Public Purchasers expressed herein are in addition to all other rights, powers and remedies possessed by the Trustee and the Public Purchasers, including, without limitation, those provided by applicable law or in any other written instrument or agreement relating to any of the Indenture Obligations or security therefor.

At the Trustee's option this Agreement, or a carbon, photographic or other reproduction of this Agreement or of any Uniform Commercial Code financing statement covering the Collateral or any portion thereof, shall be sufficient as the Uniform Commercial Code financing statement (if permitted by applicable law).

The Company agrees that the Trustee's security interest hereunder shall (notwithstanding, without limitation, that at any time or from time to time all Indenture Obligations may have been paid in full) terminate only when (a) (i) all Indenture Obligations (including, without limitation, any extensions or renewals of any thereof), (ii) all interest thereon and (iii) all expenses (including, without limitation, reasonable attorneys' fees and legal expenses) paid or incurred by the Trustee or the Public Purchasers in endeavoring to

enforce this Agreement or any document evidencing any of the Indenture Obligations to which the Trustee or any Public Purchaser is a party or of which any of the foregoing is a beneficiary shall have been finally paid in full and (b) all other obligations of the Company hereunder and thereunder have been fully performed. At such time, the Trustee, upon the request of the Company, shall release all liens on the Collateral and reassign and redeliver (or cause to be reassigned and redelivered) to the Company, or to such Person or Persons as the Company shall designate, such of the Collateral (if any) as shall not have been sold or otherwise applied by the Trustee pursuant to the terms hereof and shall still be held by it hereunder, together with appropriate instruments of reassignment and release; provided, however, if (i) the Working Capital Facility Lender releases its liens on any of the Collateral in which it has a senior security interest (other than the General Intangibles of the Company and the Company's interest in its Winnsboro, South Carolina facility) or (ii) the Company is able to refinance the Working Capital Facility without a Lien on any of the Collateral in which the Working Capital Facility Lender currently has a senior security interest, then the Trustee, upon the request of the Company in accordance with Section 2(d) hereof, shall promptly release its security interest in such Collateral (other than the General Intangibles of the Company and the Company's interest in its Winnsboro, South Carolina facility) (A) released by the Working Capital Facility Lender or (B) which no longer constitutes security for the Refinanced Working Capital Facility, and deliver appropriate instruments of release, and the subordination of the security interest of the Trustee in the General Intangibles as described in clause (c) of Section 2 shall be of no further force or effect. Any reassignment of Collateral shall be without recourse upon or representation or warranty by the Trustee, except a warranty that the Trustee has not encumbered or otherwise assigned such Collateral, and at the sole cost and expense of the Company. The Trustee agrees to execute and deliver to the Company and cause to be filed (if applicable) such documents as the Company shall reasonably request to evidence the termination of the Trustee's security interest in accordance with this paragraph.

This Agreement has been delivered at New York, New York, and shall be construed in accordance with and governed by the internal laws of the State of New York. Wherever possible each provision of this Agreement shall be interpreted in such manner as to be effective and valid under applicable law, but if any provision of this Agreement shall be prohibited by or invalid under such law, such provision shall be ineffective to the extent of such prohibition or invalidity, without invalidating the remainder of such provision or the remaining provisions of this Agreement.

The Company and the Trustee hereby waive any right to a trial by jury in any action or proceeding to enforce or defend any rights under this Agreement or any amendment, instrument, document or agreement delivered or which may in the future be delivered in connection herewith or arising from any relationship existing in connection with this Agreement, and agree that any such action or proceeding shall be tried before a court and not before a jury.




