## RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

This RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT dated as of May 13, 1999, is made by Fleet National Bank, formerly known as Fleet National Bank of Connecticut, successor by merger to Fleet Bank of Massachusetts, N.A. (the "Bank"), releases the Intellectual Property Security Agreement dated as of December 28, 1994, and recorded at the United States Patent and Trademark Office on May 22, 1995, Reel/Frame 1358/0758, and confirmed on December 31, 1996 under the Amended and Restated Revolving Credit and Security Agreement (the "Restated Agreement"), by and between BioSeptra, Inc. (the "Company") as debtor, and the Bank, as secured party, and is made in connection with the repayment of the obligations of the Company under the Revolving Credit and Security Agreement dated as of December 28, 1994 (the "Revolving Credit Agreement") and under the Restated Agreement, by and between the Bank and the Company.
