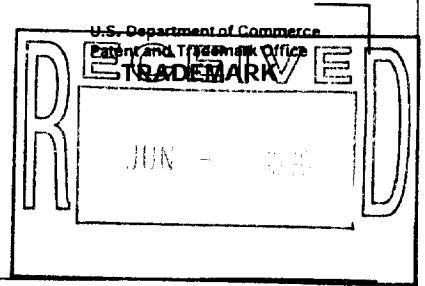

ASSIGNMENT

THIS AGREEMENT (this "Agreement") effective as of April 28, 1996 at 12:00 a.m. Eastern Standard Time, is made by and between Infonautics Corporation, a Pennsylvania corporation, at 900 West Valley Road, Suite 1000, Wayne, Pennsylvania 19087, and Infonautics Co., a Pennsylvania corporation, also at 900 West Valley Road, Suite 1000, Wayne, Pennsylvania 19087.

WHEREAS, Infonautics Corporation was the owner and then-current user of (or had a bona fide intent to use) the service marks and trademarks listed on Exhibit "A" hereto and the goodwill associated therewith (collectively, the "Property"), and had applied for registration of the service marks and trademarks listed on Exhibit "A" with the United States Patent and Trademark Office, some of which have matured into registrations as listed on Exhibit "A";

WHEREAS, as of April 28, 1996 at 12:00 a.m. Eastern Standard Time, Infonautics Co. acquired by assignment from Infonautics Corporation ownership of all right, title and interest in the Property, and succeeded to the relevant portions of Infonautics Corporation's business to which the Property pertained as required by 15 U.S.C. §1060;

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and the terms and conditions contained herein and for other good and valuable consideration, the legal sufficiency of which is hereby acknowledged by the parties, the parties hereto, intending to be legally bound, agree as follows:

Infonautics Corporation hereby sells, assigns, transfers, conveys, sets over and delivers to Infonautics Co. the whole and entire right, title and interest in and to the Property (consisting of the trademarks and service marks listed on Exhibit "A", together with any goodwill associated therewith), nunc pro tunc, now for then, effective as April 28, 1996 at 12:00 a.m. Eastern Standard Time, for whatever purposes Infonautics Co. desires.

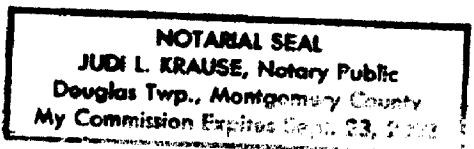
