**TRADEMARK ASSIGNMENT**

**THIS ASSIGNMENT** is made this 31<sup>st</sup> day of March 1999, between Abitibi-Consolidated Inc., a corporation incorporated under the federal laws of Canada with its principal place of business at 800 Rene-Levesque Blvd. West, P. O. Box 69, Montreal, Quebec, CANADA H3B 1Y9 and a successor by merger to Abitibi-Price Inc. ("Assignor") and United Stationers Supply Co., a corporation incorporated under the laws of the State of Illinois with its principal place of business at 2200 East Golf Road, Des Plaines, IL 60016 ("Assignee").


