
TRADEMARK ASSIGNMENT

WHEREAS, S. Assignor hereby authorizes Assignee, its successors and assigns to the fullest extent permitted by applicable law, to file in its own name applications for trademark and/or service mark registration in the United States and in foreign countries in connection with the Marks, and to secure in its own name the registrations granted thereon. Assignor hereby agrees that upon request, it will sign all necessary papers, and make all rightful oaths, and do all acts which Assignee, or its successors or assigns may consider necessary in connection with the Marks and the assignment herein to Assignee. Assignor hereby represents and warrants that it (i) has not restricted, encumbered, granted a security interest, licensed, transferred or assigned, in whole or in part, any of the Marks (other than to Assignee), (ii) has full power and authority to enter into and perform this Assignment, and (iii) has not, in any foreign country or any political subdivision thereof, applied for or obtained a trademark or service mark registrations.
