WHEREAS, Hormel Foods, LLC, a Minnesota limited liability company, having an office at 1 Hormel Place, Austin, Minnesota 55912, is desirous of acquiring any and all rights which Hormel Foods Corporation has in said listed trademarks and the goodwill of the business of Hormel Foods Corporation in connection with said trademarks.

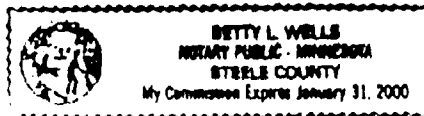
