

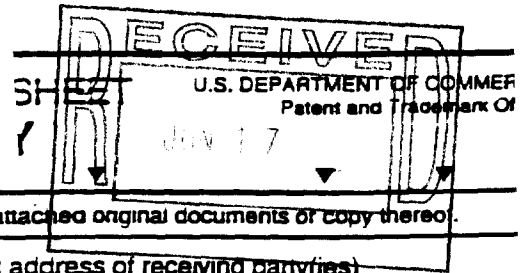

WITNESSETH:



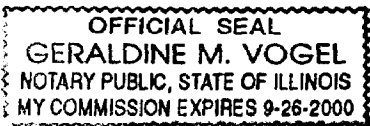
