


ASSIGNMENT

WHEREAS, Troy Technology, Inc. is desirous of acquiring the Mark and the registration thereof;



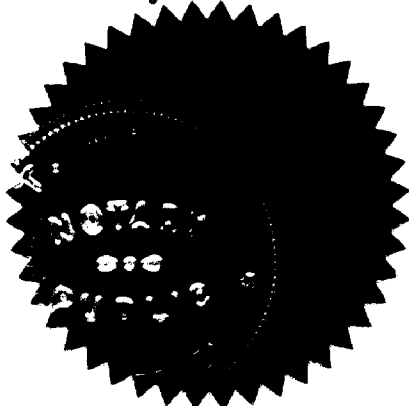
