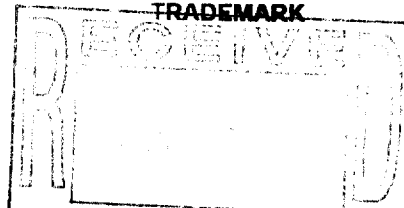

Community News Service, Inc. is the original owner of the following trademark:


INTERNET EXPRESS, Registration No. 2,213,560, registered December 29, 1998 (the "Trademark");
