ASSIGNMENT

THIS ASSIGNMENT is made as of the 10<sup>th</sup> day of December, 1997, by VISKASE SALES CORPORATION, a Delaware corporation ("VSC"), and VISKASE CORPORATION, a Pennsylvania corporation ("VC") (each of VSC and VC are sometimes referred to herein as an "Assignor"), to LINPAC ACQUISITION SUBSIDIARY, INC., a Delaware corporation ("Assignee"), pursuant to that certain Asset Purchase Agreement, dated as of the date hereof, by and among each Assignor, Assignee and certain other parties (the "Agreement"). Capitalized terms used herein without definition have the meanings given to such terms in the Agreement.

In consideration of the duties and obligations of Assignee under the Agreement, each Assignor hereby sells, assigns and transfers to Assignee, its successors, assigns or other legal representatives, the entire right, title and interest of Assignor in and to the US Intellectual Property, including, but not limited to, the trademarks and trademark registrations listed on Exhibit A attached hereto, together with the goodwill of the business symbolized or represented by such trademarks and trademark registrations, and any applications for any of the foregoing.

Each Assignor further assigns to Assignee, its successors, assigns or other legal representatives, any and all claims for damages by reason of past and continuing infringement of such US Intellectual Property, and the right to sue for and collect the same for its own use and benefit and that of its successors, assigns or other legal representatives.

Each Assignor hereby further covenants that it will, at any time and from time to time at the request of Assignee, execute, acknowledge and deliver, or cause to be done, executed, acknowledged or delivered, all such further acts and documents as Assignee may reasonably request to vest in Assignee such Assignor's full right, title and interest in and to the US Intellectual Property, or to enable Assignee to realize upon or otherwise enjoy the US Intellectual Property or to carry into effect the intent or purpose hereof or for the aiding and assisting in defending title to or reducing to possession any of the Intellectual Property to Assignee.
