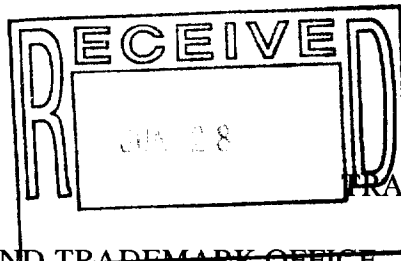

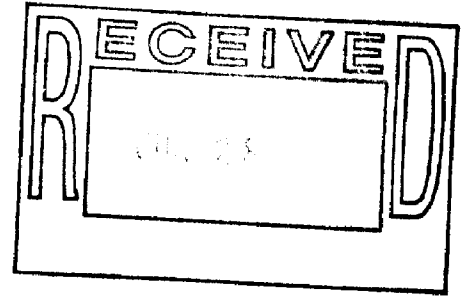



TO THE ARTICLES OF INCORPORATION OF TRUSTWORKS, INC. SECRETARY OF STATE

Pursuant to ORS 60.447, TrustWorks, Inc. (the "Corporation") has adopted an amendment to its Articles of Incorporation.

1. The name of the Corporation is TrustWorks, Inc.
2. Article I of the Articles of Incorporation is hereby amended to read in its entirety as follows:


"ARTICLE I

The name of the corporation is GeoTrust, Inc."

3. The amendment was adopted on June 4, 1999.
