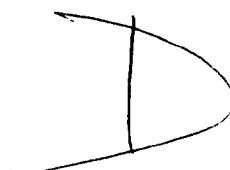

2. Article I of the Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:


"ARTICLE I. NAME
