Kelly Tompkins, Secretary of Euchem, Inc., an Ohio corporation (the "Corporation"), does hereby certify that, in a writing approved and signed by the Sole Shareholder of the Corporation as permitted by Section 1701.54 of the Ohio Revised Code, the following resolutions to amend the Articles of Incorporation of the Corporation were adopted effective February 1, 1999:


RESOLVED: That Article I of the Articles of Incorporation of the Corporation be and it hereby is amended to read in its entirety as follows:

"ARTICLE I

The name of the corporation is The Euclid Chemical Company"

RESOLVED FURTHER: That the Secretary of the Corporation be and he hereby is authorized and directed to execute and file in the office of the Secretary of State of Ohio an appropriate Certificate of Amendment to the Articles of Incorporation in order to carry out the intent and purpose of the preceding resolution and render effective said Amendment to the Articles of Incorporation.
