RELEASE OF TRADEMARK COLLATERAL

THIS RELEASE OF TRADEMARK COLLATERAL ("Release") is made as of June 4th, 1999 by Union Bank of California, N.A., a national banking association ("Bank"), the secured party under that certain Trademark Security Agreement referred to below.

WITNESSETH:

WHEREAS, National R.V., Inc., a California corporation ("Pledgor"), executed that certain Trademark Security Agreement, dated as of July 28, 1997 (the "Security Agreement"), pursuant to which Pledgor granted to Bank a security interest in certain trademarks owned and registered by Pledgor; and

Bank hereby represents and warrants that it has not heretofore transferred to any other person or entity any of the rights in and to the Released Trademarks which were granted to it pursuant to the Security Agreement.

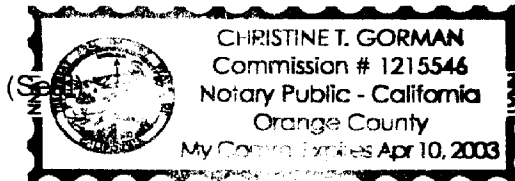
