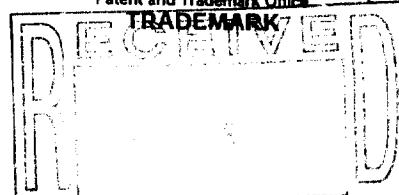

CERTIFICATE OF INCORPORATION

ALLIED-LYONS NORTH AMERICA CORP., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, **DOES HEREBY CERTIFY:**

FIRST: That at a meeting of the Board of Directors of **ALLIED-LYONS NORTH AMERICA CORP.** resolutions were duly adopted setting forth a proposed amendment to the Certificate of Incorporation of a said corporation, declaring said amendment to be advisable and calling a meeting of the stockholders of said corporation for consideration thereof. The resolution setting forth the proposed amendment is as follows:

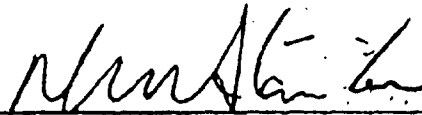
THIRD: That said amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.

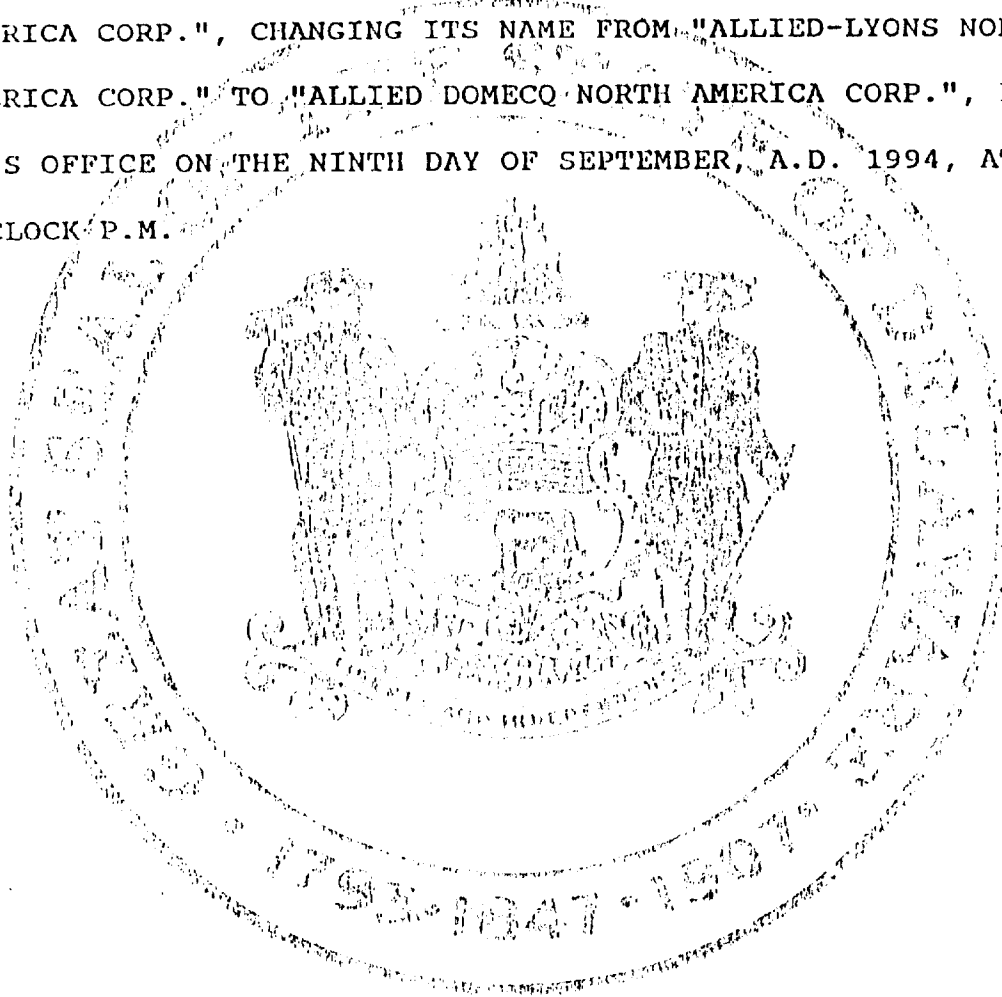
