RELEASE OF TRADEMARKS

THIS RELEASE OF TRADEMARKS is dated as of June 15, 1999 by ANTARES LEVERAGE CAPITAL CORP., n/k/a Antares Capital Corporation, a Delaware corporation ("Antares").

WHEREAS, TRIAD INFUSION PRODUCTS, INC., a Delaware corporation ("Triad"), entered into that certain Trademark Security Agreement dated as of January 23, 1996 (the "Trademark Security Agreement") in favor of Antares;

WHEREAS, the Trademark Security Agreement granted Antares a security interest in, among other things, certain trademarks, tradenames, trademark registrations, service marks, trade styles, terms, designs and trademark applications ("Trademarks") listed on Schedule A attached hereto as security for certain obligations of Triad to Antares (the "Obligations");

WHEREAS, Antares recorded the Trademark Security Agreement on August 8, 1998 at Reel 1766, Frame 0232 in the United States Patent and Trademark Office; and

WHEREAS, Triad has satisfied all of the Obligations and has requested that Antares release its security interests in the Trademarks.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Antares hereby agrees as follows:

1. Antares hereby fully releases and terminates its security interests in and liens on:
  - (a) all of Triad's now existing or hereafter acquired right, title and interest in and to: all Trademarks which are now filed with the U.S. Patent and Trademark Office, any similar office or agency of any state, territory or possession of the United States or Canada or any similar office or agency of any other country or used in the United States, any state, territory or possession thereof including, without limitation, Puerto Rico, or any other country, and any renewals thereof, all income, royalties, damages and payments now and hereafter due or payable with respect thereto, including, without limitation, payments under all licenses entered into in connection therewith and damages and payments for past or future infringements thereof, the right to sue for past, present and future infringements thereof, all documents, packages, prints and labels on which said Trademarks have appeared and all designs and general intangibles of a like nature and all rights corresponding thereto throughout the world;
  - (b) the goodwill of Triad's business connected with or symbolized by the Trademarks; and
  - (c) any and all of the proceeds of any of the foregoing, including, without limitation, any claims by Antares against third parties for infringement of the Trademarks or of any license with respect thereto.

2. Antares further agrees, at the sole cost and expense of Triad, to perform all acts reasonably necessary to effect the release and termination of its security interest and liens, including, but not limited to the recording, filing and entering into any agreements, documents forms or papers needed to accomplish such release and termination.
