

CERTIFICATE OF AMENDMENT TO ARTICLES OF INCORPORATION OF GENERAL TIRE, INC.

John C. Curry, Vice President, and Daryl L. Hollnagel, Secretary of General Tire, Inc. (the "Corporation"), an Ohio corporation, do hereby certify that, in a writing approved and signed by the Sole Shareholder of the Corporation as permitted by Section 1701.54 of the Ohio Revised Code, the following amendment to the Articles of Incorporation of the Corporation was adopted effective December 1, 1994:
