
TRADEMARK ASSIGNMENT

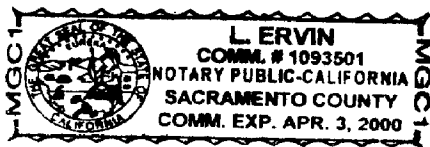
