AMENDED AND RESTATED TRADEMARK COLLATERAL ASSIGNMENT

WHEREAS, BLONDER TONGUE LABORATORIES, INC., a Delaware corporation (the "Borrower") located at One Jake Brown Road, Old Bridge, NJ 08857, has adopted, used and is using the marks shown in the attached Schedule A (the "Marks"), for which there are registrations or applications in the United States Patent and Trademark Office under the numbers shown in the attached Schedule A; and

WHEREAS, Borrower is obligated to FIRST UNION NATIONAL BANK, a national banking association ("Lender") located at 370 Scotch Road, West Trenton, New Jersey 08628, pursuant to (i) a certain Fourth Amended and Restated Loan Agreement dated as of February 1, 1999 and (ii) a certain Second Amended and Restated Security Agreement dated the date hereof made by Borrower in favor of Lender (as each may be amended, modified, restated or supplemented from time to time, collectively, the "Agreements"); and

WHEREAS, pursuant to the Agreements, Borrower is granting to Lender a security interest in the Marks, the goodwill of the business symbolized by the Marks, and the registrations and applications therefor.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Borrower does hereby assign unto Lender and grant to Lender a security interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, and registrations and applications therefor, which assignment and security interest shall secure all the Obligations as defined in the Agreements and in accordance with the terms and provisions thereof.


Borrower expressly acknowledges and affirms that the rights and remedies of Lender with respect to the assignment and security interest granted hereby are more fully set forth in the Agreements.




