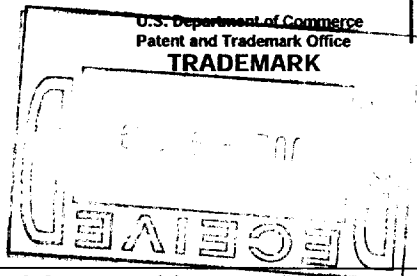

**ASSIGNMENT OF TRADEMARK**

WHEREAS, AMERICAN HOME PRODUCTS CORPORATION (“AHPC”), a corporation organized and existing under the laws of the State of Delaware, having a place of business at Five Giralda Farms, Madison, New Jersey 07940, has adopted, used, is using and, subject to the terms and provisions of an agreement with Zeneca Limited (“Zeneca”) is the owner of all right, title and interest in and to the trademark identified on Schedule A attached hereto and the United States federal and the Commonwealth or Puerto Rico registrations therefor, each also identified on Schedule A attached hereto, and the good will associated therewith (hereinafter collectively referred to as the “Trademark”); and

WHEREAS, ELAN PHARMA (INTERNATIONAL) LIMITED, a corporation organized and existing under the laws of Ireland, having a place of business at WIL House, Shannon Business Park, Shannon, County Clare, Ireland (“Elan”) is desirous of acquiring the entire right, title and interest, in and to the Trademark and the United States federal and the Commonwealth of Puerto Rico registrations therefor, and the good will associated therewith pursuant to a license agreement between AHPC and Elan, dated as of February 17, 1998, as amended, (the “Agreement”); and

WHEREAS, pursuant to a letter agreement dated February 17, 1998, Zeneca has provided its consent for AHPC to assign the Trademark to Elan, and Elan has agreed to assume all of AHPC’s obligations under the agreement with Zeneca.



Elan's assumption of all of AHPC's obligations under the agreement with Zeneca and the terms and conditions of such agreement as they may affect or relate to the Trademark, does hereby assign, transfer, sell, convey and grant to Elan, its successors and assigns the entire right, title and interest in and to the Trademark and the United States federal and the Commonwealth of Puerto Rico registrations therefor, together with the goodwill of the business symbolized by the Trademark and associated therewith.

AHPC binds itself, as well as its successors, assigns and legal representatives to execute and deliver to Elan, its successors and assigns, any further documents or instruments and do any and all further acts that may be necessary, to vest in Elan, its successors and assigns, the title herein conveyed, or intended so to be, and to enable such title to be recorded in the United States Patent and Trademark Office and the counterpart agency or office in Puerto Rico.


