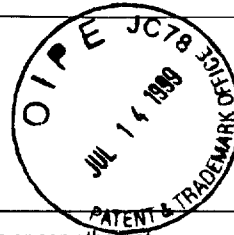

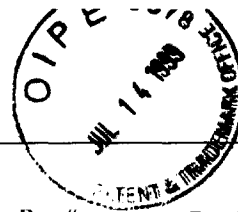

WORLDWIDE TRADEMARK ASSIGNMENT

2. Assignor shall take whatever further actions are reasonably requested by Assignee to properly and completely effect the transfer to Assignee of the Trademarks, including, without limitation, executing such further assignments of the Trademarks as are reasonably requested by Assignee in the event the transfer to Assignee of any pending applications for the Trademarks can not be effected as of the date of this assignment.
3. Assignor hereby requests that the United States Assistant Commissioner for Trademarks, and the Officials of all other countries whose duty it is to record trademark registrations, applications, and the title thereto, record the Trademarks as the property of Assignee and issue in the name of Assignee all registrations maturing from pending applications filed by Assignor.


4. Assignee hereby accepts this assignment.
