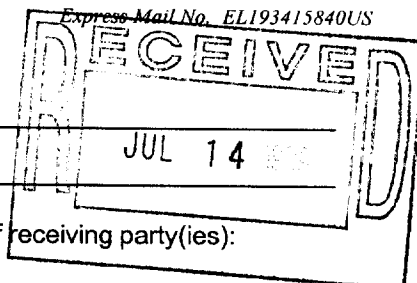

ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION
OF
NSC, L.L.C.

Pursuant to the provisions of Section 29-633 of the Arizona Revised Statutes, the undersigned limited liability company hereby adopts the following Articles of Amendment to its Articles of Organization originally filed with the Arizona Corporation on March 24, 1998:
