Certificate of Amendment of Certificate of Incorporation

of

Under Section 805 of the Business Corporation Law

We the undersigned, Robert K. Scribner and John J. O'Connor, being respectively the President and Secretary of Esselte Pendaflex Corporation hereby certify that:

FIRST:

The name of the corporation (hereinafter called the "Corporation") is Esselte Pendaflex Corporation. The name under which the corporation was formed is Soorum and Pease Company.

SECOND:

The certificate of incorporation of the corporation was filed by the Department of State on December 28, 1897.

THIRD:

The amendment of the certificate of incorporation of the corporation effected by this certificate of amendment is as follows: To change the name of the corporation.

FOURTH:

To accomplish the foregoing amendment, Article First of the certificate of incorporation of the corporation, relating to the name of the corporation is hereby amended to read as follows:

"The name of the corporation is amended to read Esselte Corporation."

FIFTH:

The foregoing amendment of the certificate of incorporation of the corporation was authorized by the written consent of the Board of Directors of the corporation, followed by the written consent of the sole shareholder of all of the outstanding shares of the corporation entitled to vote on the said amendment of the certificate of incorporation.
