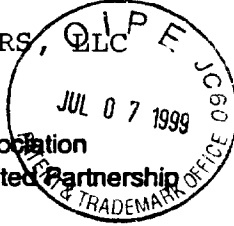

ASSIGNMENT OF TRADEMARKS

WHEREAS, in connection with the effectuation of the transactions contemplated in a certain Agreement for Purchase and Sale of Stock of DSC Enterprises, Inc. by and among the shareholders of DSC Enterprises, Inc. and Protection One Alarm Monitoring, Inc. dated as of May 12, 1998, Assignor has agreed to assign to Assignee the Marks and the registrations and applications thereof;
