


## TRADEMARK ASSIGNMENT

Waccamaw covenants that, subject to the terms and conditions of the Merger Agreement, it will do or cause to be done all such further acts, and shall execute and deliver, or cause to be executed and delivered, all deeds, transfers, assignments, conveyances, evidences of title, notices, powers of attorney, and assurances necessary or desirable to better assure and confirm HomePlace's title to the Trademarks.

This Assignment shall be deemed to be effective as of and from the day hereof.
