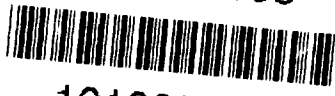




PROCEEDINGS SUSPENDED FOR CIVIL ACTION
