# ASSIGNMENT OF TRADEMARK




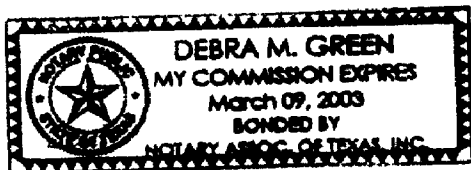
