## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS is made as of this 14 day of June, 1999, by Harris Trust and Savings Bank, an Illinois banking corporation (the "Grantee"), in favor of JPS Packaging Company, a Delaware corporation ("Grantor").

WHEREAS, pursuant to the terms of that certain Trademark and License Security Agreement (the "Trademark Security Agreement") dated June 30, 1998, by and between Grantor and Grantee, Grantor granted to Grantee a continuing security interest in all of Grantor's right, title and interest in and to, among other things, the trademark registrations and trademark applications listed on Schedule A hereto (collectively, the "Trademarks"); and

NOW, THEREFORE, Grantee, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, hereby terminates, cancels and releases the Trademark Security Agreement with respect to the trademark registrations and trademark applications listed on Schedule A attached hereto and any and all security interests it has against any of the Trademarks listed on Schedule A hereto insofar, and only insofar, as the above trademarks and trademark applications were sold by the Grantor to Axon Corporation pursuant to that certain Asset Purchase Agreement dated as of June 14, 1999 by and among the Grantor and Venture Packaging, Inc. as seller and said Axon Corporation as purchaser.

FURTHER, Grantee represents and warrants that it has the full power and authority to execute this Release of Security Interest in Trademarks, that it has not assigned, transferred, restricted or otherwise encumbered its security interest in the Trademarks.

FURTHER, Grantee hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release of Security Interest in Trademarks.

THIS IS A PARTIAL RELEASE ONLY; EXCEPT AS TO THE TRADEMARK AND TRADEMARK APPLICATIONS SPECIFICALLY LISTED ON SCHEDULE A ATTACHED HERETO, THE SECURITY INTEREST GRANTED BY THE TRADEMARK AND LICENSE SECURITY AGREEMENT BETWEEN THE GRANTOR AND THE GRANTEE DATED AS OF JUNE 30, 1998 CONTINUES IN FULL FORCE AND EFFECT TO THE SAME EXTENT AS IF THIS RELEASE HAD NOT BEEN DELIVERED.

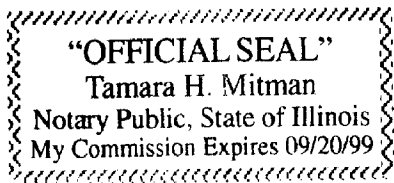
