



ARTICLES OF AMENDMENT

to the

ARTICLES OF INCORPORATION

of

ENVIRONMENTAL FEDERATION OF AMERICA

To: Department of Consumer and Regulatory Affairs
Corporation Division
Washington, D.C.

THE UNDERSIGNED, pursuant to the District of Columbia Nonprofit Corporation Act, hereby adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: The name of the Corporation is: Environmental Federation of America.

SECOND: The following amendment to the Articles of Incorporation was adopted by the Corporation in the manner prescribed by the District of Columbia Nonprofit Corporation Act:

The name of the Corporation is changed to: Earth Share.

THIRD: The amendment was approved by unanimous written consent of the directors and adopted at a meeting of members held on March 23, 1999 at which a quorum was present, and the amendment received at least two thirds of the votes which members present or represented by proxy at such meeting, were entitled to cast.
