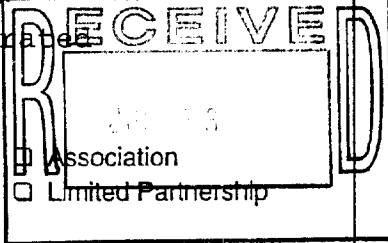

**TRADEMARK ASSIGNMENT**
