TRADEMARK

UNITED STATES TRADEMARK ASSIGNMENT

WHEREAS, Christopher W. Walker, an individual and citizen of the United States of America, hereinafter referred to as "ASSIGNOR," has adopted and used and is the owner of the trademark EMIX (U.S. Reg. No. 1,737,507) (the "Mark"), together with the goodwill of the business in connection with which the Mark has been used (the "Goodwill"), and the United States Trademark Registration for the Mark (the "Registration"); and


WHEREAS, Commix Corporation, a corporation duly organized and existing under the laws of the State of Virginia, hereinafter referred to as "ASSIGNEE," is desirous of acquiring the Mark, together with the Goodwill and the Registration;

NOW, THEREFORE, for One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR has agreed to sell and has sold, assigned, transferred and set over, and by these presents does sell, assign, transfer and set over unto ASSIGNEE and its successors and assigns ASSIGNOR'S entire right, title and interest in and to the Mark, the Goodwill and the Registration, to be held and enjoyed by ASSIGNEE for its own use and benefit and for the use and benefit of its successors, assigns and legal representatives, for the full extent of the life of the Mark and the term of the Registration, to be used as fully and entirely as such rights would have been held and enjoyed by ASSIGNOR had this Assignment and sale not been made.

ASSIGNOR covenants that ASSIGNOR is the owner of the Mark and the holder of record title to the Registration, and that ASSIGNOR has full power to make this Assignment.
