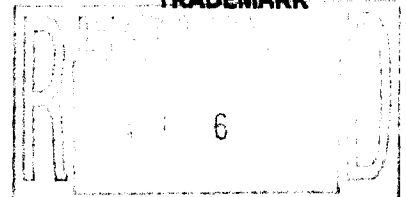

**TERMINATION AND RELEASE OF LIEN ON AND
SECURITY INTEREST IN TRADEMARKS**

WHEREAS PORT CITY PRESS, INC., a Maryland corporation with a mailing address at 1323 Greenwood Road, Baltimore, Maryland 21208, U.S.A. ("BORROWER") and FLEET CAPITAL CORPORATION, a Rhode Island corporation with an office at 200 Glastonbury Boulevard, Glastonbury, Connecticut 06033, U.S.A. NOW THEREFORE, in consideration of the foregoing and intending to be legally bound, LENDER hereby releases and terminates the Security Interest and waives and relinquishes all its rights, powers, privileges and remedies with respect to BORROWER, its successors and assigns, under the Security Agreement, including without limitation, all rights in and to the Trademarks.
