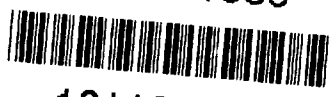

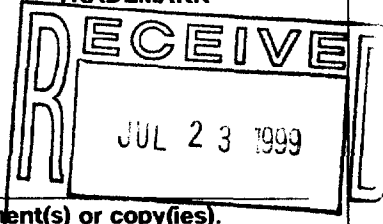

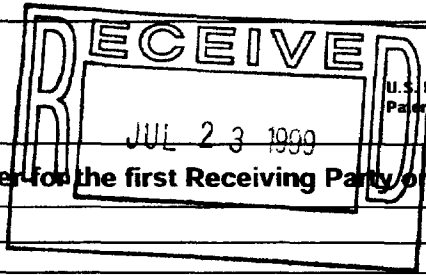

DAWSON INTERNATIONAL HOLDINGS (UK) LIMITED, a company incorporated in Scotland with registered number SC54674 and having its registered office at Lochleven Mills, Kinross GY13 7GL (hereinafter referred to as the "Assignee")

WHEREAS

- (A) The Assignor is the lawful proprietor of certain Intellectual Property Rights (as defined below); and
- (B) The Assignor is willing, as requested by the Assignee, to transfer to the Assignee all the said Intellectual Property Rights.

NOW IT IS HEREBY AGREED AS FOLLOWS:-

1. DEFINITIONS

In this Assignment the following terms shall have the following meanings unless the context otherwise requires:

Effective Date means 3rd January 1998;

Intellectual Property Rights means all registrations of and pending applications for the trade marks listed in the Schedule to this Assignment, together with the rights to make future applications and to sue for any and all past infringements; and (to the extent vested in the Assignor) all copyright, United Kingdom design right and technical information and know-how relating to the Products;

Products means knitwear, textiles and other garments made and/or sold by the Assignor in the course of its business; and

Schedule means the Schedule annexed to and forming part of this Agreement;

2. ASSIGNATION

The Assignor hereby assigns to the Assignee all its property right title and interest in the Intellectual Property Rights, and hereby undertakes at the request and cost of the Assignee to execute all such further documents, forms and authorisations as may be required to vest full right title and interest in the Intellectual Property Rights in the Assignee absolutely, including but not limited to registration of the Assignee's title as proprietor at relevant trade mark registries anywhere in the world.

3. WARRANTIES

3.1 The Assignor hereby warrants represents and undertakes to the Assignee as follows:-

- (a) it has full power to enter into and perform this Assignment, and this Assignment constitutes binding obligations on it in accordance with its terms; and
- (b) the Intellectual Property Rights which are the subject of registration are its sole absolute property free from encumbrances, free and clear of any security interest or third party rights.

4. DELIVERABLES

4.1 Upon the Effective Date the Assignor shall deliver to the Assignee, insofar as capable of delivery and not being already in the Assignee's possession, all agreements and records and technical information relating to the Intellectual Property Rights.

4.2 The Assignor has instructed the patent agents, Marks & Clerk (of 57-60 Lincoln's Inn Fields London WC2A 3LS) (the "Patent Agents") that all records and technical information which the Patent Agents hold relating to the Intellectual Property Rights are to be held to the order of the Assignee from the Effective Date.

5. GOVERNING LAW
