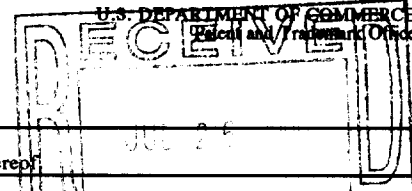

AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT

(Borrower)

THIS AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT (“Agreement”) is between KERR GROUP, INC., a Delaware corporation (“Debtor”), and NATIONSBANK, N.A., a national banking association (“Secured Party”), acting in its capacity as Administrative Agent pursuant to that certain Amended and Restated Credit Agreement dated as of March 12, 1999 (the “Credit Agreement”) among Debtor, Secured Party, NationsBanc Montgomery Securities LLC and Wells Fargo Bank, N.A., and each of the “Lenders” party thereto.

R E C I T A L S:

A. Debtor and Secured Party are parties to that certain Trademark Security Agreement dated as of August 26, 1997 (the “Original Trademark Agreement”) and that certain Loan and Security Agreement dated as of August 26, 1997 (as amended, the “Original Security Agreement”).

B. Debtor and Secured Party have entered into that certain Pledge and Security Agreement dated as of March 12, 1999 (as the same may be renewed, extended, amended, modified, restated, supplemented, and in effect from time to time, the “Security Agreement”; all terms defined in the Security Agreement, wherever used herein, shall have the same meanings herein as are prescribed by the Security Agreement).

C. Pursuant to the terms of the Security Agreement, (i) Debtor has granted to Secured Party a lien and security interest in all General Intangibles of Debtor, including, without limitation, all of Debtor’s right, title, and interest in, to and under all now owned and hereafter acquired Trademarks, together with the goodwill of the business symbolized by Debtor’s Trademarks, and Trademark Licenses, and all products and Proceeds thereof, to secure the payment of the Obligations (as defined in the Credit Agreement) and (ii) the lien and security interest of Secured Party under the Original Security Agreement in all General Intangibles of Debtor has been amended, restated and continued.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Debtor hereby grants to Secured Party a lien and continuing security interest in all of Debtor’s right, title, and interest in, to and under the following (all of the following items or types of property being herein collectively referred to as the “Trademark Collateral”), whether presently existing or hereafter created or acquired:

(1) each Trademark, trademark registration (“Trademark Registration”), and trademark application (“Trademark Application”), including, without limitation, each Trademark, Trademark Registration, and Trademark Application referred to in Schedule 1 annexed hereto, together with the goodwill of the business symbolized thereby; and

(2) each Trademark License, including, without limitation, each Trademark License referred to in Schedule 1 annexed hereto; and

(3) all products and Proceeds of the foregoing, including, without limitation, any claim by Debtor against third parties for past, present, or future (a) infringement, dilution, or breach of any Trademark, Trademark Registration, Trademark Application, or Trademark License, including, without limitation, any Trademark, Trademark Registration, or Trademark License referred to in Schedule 1 annexed hereto, and any Trademark Registration issued pursuant to a Trademark Application referred to in Schedule 1 annexed hereto; or (b) injury to the goodwill associated with any Trademark, Trademark Registration, or Trademark Application.

The lien and security interest contained in this Agreement is granted in conjunction with the liens and security interests granted and continued pursuant to the Security Agreement. This Agreement amends and restates in its entirety the Original Trademark Agreement. All liens and security interests created under and/or evidenced by the Original Trademark Agreement shall continue to be created under and/or evidenced by this Agreement, with the same perfection and priority under this Agreement as existed under the Original Trademark Agreement. This Agreement shall not constitute an extinguishment, discharge, satisfaction, or novation of any indebtedness, liabilities, or obligations of Debtor under the Original Trademark Agreement.

Debtor hereby acknowledges and affirms that the rights and remedies of Secured Party with respect to the liens and security interests in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

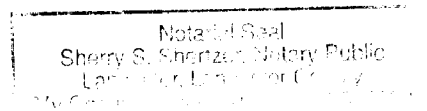

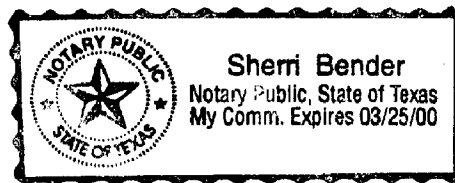
