

WHEREAS, Assignor is the owner of the trademarks identified in Exhibit A attached hereto and made a part hereof (the "Marks"); and


WHEREAS, Assignee is desirous of obtaining ownership of the Marks, together with the goodwill of the business pertaining thereto;
