

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF CNMC CHILD VENTURES

Pursuant to the provisions of the District of Columbia Nonprofit Corporation Act, the undersigned domestic corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of

The name of the corporation is CNMC Child Ventures.

SECOND: The following amendments to the Articles of Incorporation were adopted by the corporation in the manner prescribed by the District of Columbia Nonprofit Corporation Act.

ARTICLE I is hereby deleted in its entirety and replaced with the following:

Name

The name of the corporation shall be:

NATIONAL SAFE KIDS

ARTICLE III(a) is hereby deleted in its entirety and replaced with the following:

Purpose

a) The Corporation is organized and shall be operated exclusively for charitable, scientific, and educational purposes to assist and support Children's Hospital in the provision of healthcare and related services, so long as Children's Hospital is exempt from federal income tax under Section 501(a) of the Internal Revenue Code of 1986, as amended, or successor provisions (the "Code") as an organization described in Section 501(c)(3) of the Code, and which is described in Section 509(a)(1) or Section 509(a)(2) of the Code, including programs to encourage and advance the health and well-being of children and programs for the prevention of unintentional injury in children.

THIRD:

The amendment was adopted in the following manner:



The amendment was adopted at a meeting of the sole member held on 1999 at which a quorum was present, and the amendment received at least two-thirds of the votes which members present or represented by proxy at such meeting were entitled to cast.
