# TERMINATION AND RELEASE OF SECURITY INTEREST ASSIGNMENT OF TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTEREST ASSIGNMENT OF TRADEMARKS (the "Release") made as of the 19th day of July, 1999, by ULTRA BUILDING SYSTEMS, INC., a New Jersey corporation ("Ultra") and USA WINDOWMAN, INC., a Pennsylvania corporation ("USA").

- 2. The parties hereto, Ultra and USA, agree to cancel and terminate and do hereby cancel and terminate all rights of USA and obligations of Ultra created solely under the Assignment.
- 3. This Release has been executed and delivered in, and shall be governed by and construed in accordance with the laws of the State of Texas.
