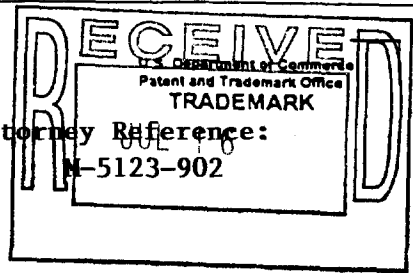

## ASSIGNMENT OF MARKS

**THIS AGREEMENT** is made effective as of this 7<sup>th</sup> day of June, 1999, by Discreet Logic (Desktop) Inc., a Barbados Corporation located at Law Chambers, 1<sup>st</sup> Floor, James Fort Building, Hincks Street, Bridgetown, Barbados ("Assignor"), in favor of Autodesk, Inc., a Delaware Corporation with principal offices at 111 McInnis Parkway, San Rafael, California, 94903 United States of America ("Assignee").

**WHEREAS**, Assignor owns certain rights in the trademark ILLUMINAIRE, including U.S. Application Serial Number 75/090,151, together with the goodwill of the business in connection with which said ILLUMINAIRE trademark has been used or is intended to be used;

**WHEREAS**, Assignee desires to acquire all of Assignor's rights, title and interest in and to the trademark ILLUMINAIRE together with the goodwill of the business in connection with which said trademark has been used or is intended to be used;

**NOW THEREFORE**, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged:

1. Assignor hereby assigns, sells, transfers, conveys, and grants to Assignee all of Assignor's right, title, and interest in and to the ILLUMINAIRE trademark, including but not limited to the U.S. Application Serial Number 75/090,151 for said trademark, in the United States and worldwide, together with the goodwill of the business in connection with which said trademark has been used or is intended to be used.
2. Assignor further hereby assigns, sells, transfers, conveys, and grants to Assignee all rights of action at law and suits in equity, if any, to recover for past infringements of the ILLUMINAIRE trademark, as well as its right, if any, to apply for and the privilege of applying for and maintaining registration of said trademark, the same to be held and enjoyed by Autodesk, Inc. as fully and completely as by Discreet Logic (Desktop) Inc. had this assignment not been made.
