## ASSIGNMENT NUNC PRO TUNC

WHEREAS, Jaye-Boern Laboratories, Inc., an Illinois corporation now dissolved and formerly having a mailing address at 1535 Lake Cook Road, Northbrook, Illinois 60062 (hereinafter the "Corporation"), is the record owner of U.S. Trademark Registration No. 1,257,304 for the mark SUNSOAP, issued on November 15, 1983; and

WHEREAS on September 1, 1992 the Corporation was dissolved and the assets of the Corporation were distributed to Joel E. Bernstein, M.D., having a mailing address of 615 Brierhill Road, Deerfield, IL 60015.
