

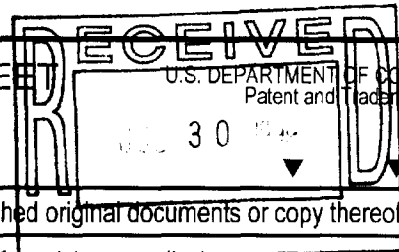

REASSIGNMENT AND RELEASE OF SECURITY INTEREST

This Reassignment and Release of Security Interest is made as of July 22, 1999 by FINOVA MEZZANINE CAPITAL INC., a Tennessee corporation (f/k/a SIRROM CAPITAL CORPORATION), with its principal place of business at 500 Church Street, Suite 200, Nashville, Tennessee 37219 ("SECURED PARTY") to VISTA INFORMATION SOLUTIONS, INC., a Minnesota corporation with its principal place of business at 5060 Shoreham Place, Suite 300, San Diego, CA 92122 ("DEBTOR").
