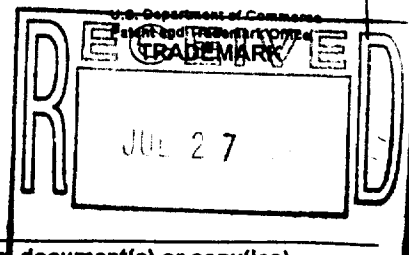

TERMINATION AND RELEASE OF SECURITY INTEREST IN CERTAIN PATENTS, TRADEMARKS AND COPYRIGHTS

WHEREAS Futorian Furnishings, Inc. (formerly known as Furniture Comfort Corporation which in turn was formerly known as Mohasco Upholstered Furniture Corporation) ("Futorian") and various other third parties (collectively, the "Other Debtors") entered into a Credit Agreement, dated September 22, 1989 (the "Credit Agreement") with Court Square Capital Limited (formerly known as Citicorp Capital Investors, Ltd.) ("Court Square");

WHEREAS in connection with the Credit Agreement, Futorian and the Other Debtors entered into a Continuing Security Interest and Conditional Assignment of Patents, Trademarks, Copyrights, and Licenses, dated September 22, 1989 (the "Continuing Security Interest"), pursuant to which they granted Court Square a continuing security interest (the "Security Interest") in various intellectual property assets, including certain Patents, Trademarks (and associated goodwill), Copyrights and Licenses (as such terms are defined in the Continuing Security Interest) owned by Futorian (collectively, the "Futorian Intellectual Property Assets");

WHEREAS, the Continuing Security Interest was recorded in the U.S. Patent and Trademark Office at Reel No. 0673 and Frame No. 0118 et. seq. and then again subsequently at Reel No. 0727 and Frame No. 0555 et seq.;

AND WHEREAS, Court Square desires to release the Security Interest as to all of the Futorian Intellectual Property Assets that are used in connection with the Stratford Division of Futorian (collectively, the "Stratford Division Intellectual Property Assets");

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to legally bound, Court Square hereby releases and terminates the Security Interest with respect to all of the Stratford Division Intellectual Property Assets, including, without limitation, the trademark registrations and applications listed in Schedule A (and all goodwill associated therewith), hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to Futorian, and its successors and assigns under the Credit Agreement with respect to such Stratford Division Intellectual Property Assets, hereby assigns, transfers and sets over to Futorian, its successors and assigns any right, title or interest in or to such Stratford Division Intellectual Property Assets that Court Square may have acquired, and hereby releases Futorian, and its successors and assigns from all of Futorians's covenants, obligations, liabilities and warranties under the Credit Agreement with respect to such Stratford Division Intellectual Property Assets.

Nothing herein shall release, modify or alter Court Square's rights with respect to any Futorian Intellectual Property Assets other than the Stratford Division Intellectual Property Assets or any assets of any Other Debtors under the Credit Agreement or the Security Interest.
