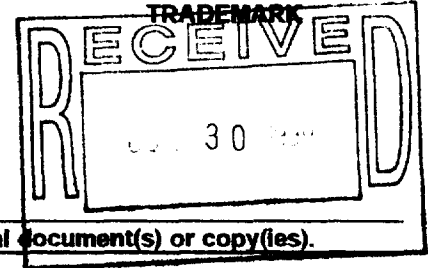

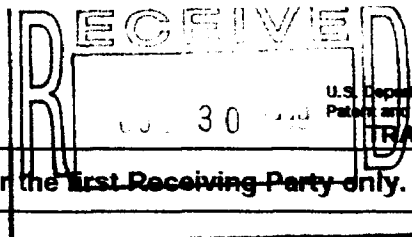


1. The name of the corporation (hereinafter called the "corporation") is RDI Acquisition Corp.
