**ASSIGNMENT AND RELEASE OF  
ASSIGNMENT FOR SECURITY  
(TRADEMARKS AND TRADEMARK LICENSES)**

**RECITALS**

A. Pursuant to that certain Assignment for Security (Trademarks and Trademark Licenses), dated as of July 15, 1998, and recorded with the U.S. Patent and Trademark Office on July 22, 1998, at Reel 1769, commencing at Frame 0663, by Belvedere Winery, L.P., a California limited partnership, Belvedere Wine Company, a California corporation, and William R. Hambrecht, as trustee of The Hambrecht 1980 Revocable Trust, and not in his individual capacity, collectively as Borrower, in favor of The Travelers Insurance Company, a Connecticut corporation, as Lender, Borrower granted to Lender a security interest in and lien on all of Borrower's interest in and to the Trademark Collateral (as defined therein).

B. Lender desires to release its security interest in and lien on the Trademark Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby releases its security interest in and lien on the Trademark Collateral including, without limitation, the trademarks set forth in the attached Schedule 1, and reassigns to Borrower, without representation or warranty, express or implied, and without recourse, all right, title and interest of Lender in and to Borrower's interest in such Trademark Collateral.
