
AND WHEREAS, CGC wishes to acquire said trademark, the registration therefor, and the business and good will of the business in connection therewith.

This Confirmatory Assignment of Trademark is pursuant to the purchase by CGC of the net assets of The ConSelltant Group, an Ohio S corporation wholly owned by Orlowski, dated as of January 2, 1996.
