CALIFORNIA COMMUNITY NEWS CORPORATION

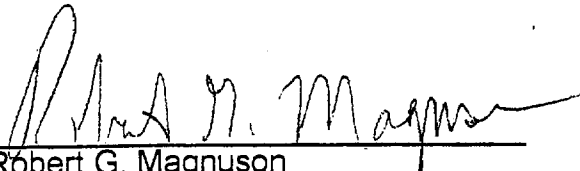
