Assignor agrees that at the request of Assignee, Assignor will, without additional consideration, execute any documents deemed reasonably necessary by Assignee:


- (a) to vest all rights, title, and interest of Assignor, if any, in the Marks and Name in Assignee or any party designated by Assignee; and
