

IN WITNESS WHEREOF, Garlock Inc has caused this Trademark Assignment to be executed and delivered as of this 27th day of September, 1999.

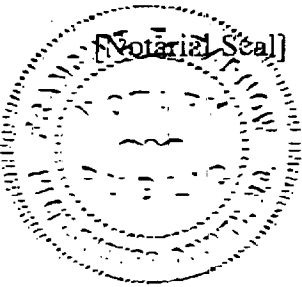
